

- 4. **Binder:** Polyester flat thread binder tape applied for cables with more than 5 conductors
- 5. **Shielding:** 5 mils tape shield
- 6. Rip Cord: Rip cord for ease of jacket removal
- 7. Overall Jacket: Thermoplastic SOLONON® Low Smoke Zero Halogen (LSZH-TP) Jacket

Southwire's 600 Volt control cables are suited for use in wet and dry areas, conduits, ducts, troughs, trays, direct burial, aerial supported by a messenger, and where superior electrical properties are desired. These cables are capable of operating continuously at the conductor temperature not in excess of 90°C for normal operation in wet and dry locations, 130°C for emergency overload, and 250°C for short circuit conditions. UL rated constructions can be used in Class I, II, and III, Division 2 hazardous locations per NEC Article 501 and 502.
