

- 1. Conductor: Class B compressed stranded bare copper per ASTM B3 and ASTM B8
- 2. Insulation: Fire Retardant Cross Linked Polyethylene (FR-XLPE)
- 3. **Grounding Conductor:** Class B compressed stranded bare copper per ASTM B3 and ASTM B8 for cables with 3 or 4 conductors
- 4. Filler: Paper or Polypropylene filler
- 5. Binder: Polyester flat thread binder tape
- 6. Shield: 5 mil copper Helically-Applied Tape shield
- 7. Rip Cord: Rip cord for ease of jacket removal
- 8. Overall Jacket: Polyvinyl Chloride (PVC) Jacket

APPLICATIONS AND FEATURES:

Southwire's 600 Volt control cables are suited for use in wet and dry areas, conduits, ducts, troughs, trays, direct burial, aerial supported by a messenger, and where superior electrical properties are desired. These cables are capable of operating continuously at the conductor temperature not in excess of 90°C for normal operation in wet and dry locations, 130°C for emergency overload, and 250°C for short circuit conditions. UL rated constructions can be used in Class I, II, and III, Division 2 hazardous locations per NEC Article 501 and 502. UL rated constructions with 3 or more conductors are listed for exposed runs (TC-ER) per NEC 336.10.
