### **CONSTRUCTION:**

1. **Conductor:** 7 strands class B compressed bare copper per ASTM B3 and ASTM B8
2. **Insulation:** Cross Linked Polyethylene (XLPE) XHHW-2, 30 Mils thick for all cable sizes
3. **Grounding Conductor:** Class B compressed stranded copper with green insulation
4. **Filler:** Polypropylene filler
5. **Overall Jacket:** Polyvinyl Chloride (PVC) Jacket

### **APPLICATIONS AND FEATURES:**

Southwire's 600 or 1000 Volt Type TC-ER control cables are suited for use in wet and dry areas, conduits, ducts, troughs, trays, direct burial, aerial supported by a messenger, and where superior electrical properties are desired. These cables are capable of operating continuously at the conductor temperature not in excess of 90°C for normal operation in wet and dry locations, 130°C for emergency overload, and 250°C for short circuit conditions. For uses in Class I, II, and III, Division 2 hazardous locations per NEC Article 501 and 502. Constructions with 3 or more conductors are listed for exposed runs (TC-ER) per NEC 336.10.
