- 4. Filler: Paper filler (cable size 8 & 6 uses Polypropylene filler)
- 5. Binder: Polyester flat thread binder tape for cable sizes larger than 2 AWG
- 6. Overall Jacket: Polyvinyl Chloride (PVC) Jacket
