

- 3. **Filler:** Polypropylene filler on cables with 5 or less conductors
- 4. **Binder:** Polyester flat thread binder tape applied for cables with more than 5 conductors
- 5. **Drain Wire:** Bare copper drain wire. Tinned copper drain wire available upon request.
- 6. **Shield:** 5 mils copper Longitudinally-Applied Corrugated Tape (LCT) shield
