### **CONSTRUCTION:**

- 1. **Conductor:** 7 strands class B compressed bare copper per ASTM B3 and ASTM B8
- 2. Insulation: Flame Retardant Cross Linked Polyethylene (FR-XLPE), 30 Mils thick for all control cable sizes
- 3. **Filler:** Polypropylene filler on cables with 5 or less conductors
- 4. **Binder:** Polyester flat thread binder tape applied for cables with more than 5 conductors
- 5. **Shield:** 5 mils copper Longitudinally-Applied Corrugated Tape (LCT) shield
- 6. Rip Cord: Rip cord for ease of jacket removal
- 7. Overall Jacket: Thermoplastic SOLONON® Low Smoke Zero Halogen (LSZH-TP) Jacket

#### **APPLICATIONS AND FEATURES:**

Southwire's 600 Volt control cables are suited for use in wet and dry areas, conduits, ducts, troughs, trays, direct burial, aerial supported by a messenger, and where superior electrical properties are desired. These cables are capable of operating continuously at the conductor temperature not in excess of 90°C for normal operation in wet and dry locations, 130°C for emergency overload, and 250°C for short circuit conditions. UL rated constructions can be used in Class I, II, and III, Division 2 hazardous locations per NEC Article 501 and 502. UL rated constructions with 3 or more conductors are listed for exposed runs (TC-ER) per NEC 336.10. Ruggedized rodent-resistant designs can be customized.
