

# **CONSTRUCTION:**

- 1. **Conductor:** 7 strands class B compressed bare copper per ASTM B3 and B8. Tinned copper available upon request.
- 2. Insulation: Cross Linked Polyethylene (XLPE) Type XHHW-2 when UL listed
- 3. Filler: Polypropylene filler on cables with 5 or less conductors
- 4. Binder: Polyester flat thread binder tape applied for cables with more than 5 conductors
- 5. Drain Wire: Bare copper drain wire. Tinned copper drain wire available upon request.
- 6. Shield: 5 mils copper Longitudinally-Applied Corrugated Tape (LCT) shield
- 7. **Rip Cord:** Rip cord for ease of jacket removal
- 8. Overall Jacket: Thermoplastic Chlorinated Polyethylene (CPE-TP) Jacket

# **APPLICATIONS AND FEATURES:**

Southwire's 600 Volt Type TC-ER<sup>1</sup> power or control cables are suited for use in wet and dry areas, conduits, ducts, troughs, trays, direct burial, aerial supported by a messenger, and where superior electrical properties are desired. These cables are capable of operating continuously at the conductor temperature not in excess of 90°C for normal operation in wet and dry locations, 130°C for emergency overload, and 250°C for short circuit conditions. For uses in Class I, II, and III, Division 2 hazardous locations per NEC Article 501 and 502. Constructions with 3 or more conductors are listed for exposed runs (TC-ER) per NEC 336.10.
