

- 4. **Filler:** Polypropylene filler on cables with 5 or less conductors
- 5. **Overall Jacket:** Thermoplastic Chlorinated Polyethylene (CPE-TP)

### **APPLICATIONS AND FEATURES:**

Southwire's 600 Volt Type TC-ER control cables are suited for use in wet and dry areas, conduits, ducts, troughs, trays, direct burial, aerial supported by a messenger, and where superior electrical properties are desired. These cables are capable of operating continuously at the conductor temperature not in excess of 90°C for normal operation in wet and dry locations, 130°C for emergency overload, and 250°C for short circuit conditions.
